# 6. ADVISORY BOARD WELCOME, INTRODUCTIONS, AND COMMENTS FROM CHAIR \*FOR DISCUSSION\* – Stavros Anthony, Chair

New members: Alex Bacchus - Governor's Office of Economic Development, Staci Emm - Nevada Indian Commission, Greg Juhl – Public Health, Rafael Villanueva – Travel Nevada

Chair: Access to outdoor recreation can have a significant positive impact on health outcomes for people, including physical, cognitive, and mental health. which includes the cost of entry, lack of transportation, and access to information. While state investments in Outdoor recreation has been building in recent years, it is still not sufficient to address the barriers and challenges outlined above. We are dealing with public health when it comes to this board.

Everyone was provided with a copy of the new Travel Nevada Magazine.

Robert Mergell: Cave Lake update - Has been under construction since 2019 to prevent the lake from having a catastrophic failure. Since then, the reservoir has been drained. It is now finished. The lake was projected to fill in the spring but filled quicker. The re-opening will be on June 7<sup>th</sup>.

Chair: AB 53 – The first part mandates 20 minutes of outdoor recreation for children in grades K-5. The second part authorizes school boards to come up with outdoor recreation activities that kids can complete to get school credit to graduate.

Debra Stickland: If you were a high school rodeo participant, could you get credits for graduation with this bill?

Chair: It's up to the school board.

7. DIVISION UPDATES \*FOR DISCUSSION\* Denise Beronio, Administrator, Elisabeth Jonhson, Deputy Administrator, \*Kendal Scott, Outdoor Education Lead, Jasmina Sekanovich, GIS Mapping Analyst, Chelsea Kincheloe, Program Officer & Comms Lead, Kaden Barmore, OHV Program Manager and Katy Huneycutt, Management Analyst: may provide updates as they apply regarding division activities, partnerships, opportunities, challenges, initiatives, collaborations, relevant public lands updates, state legislative updates, accomplishments, as well as ongoing and upcoming projects. \* Discuss NOER Grant feedback from TAC

Denise Beronio: Has been working with Cheva Gabor on Tahoe Meadows Project. The goal is to address critical winter safety concerns at Tahoe Meadows due to overcrowding. Currently reaching out to partners and stakeholders for initial feedback. Hoping to move to a request for proposal (RFP) to hire a master planning contractor. The goal is to have the master plan in motion by early next year, 2026. Legislative session - SB 21 will expand the NOER Grant Program to create a second bucket for the public to create grant opportunities outside the K-12 realm. It will now also include infrastructure. AB165 creates a council that expands the advisory working group. AB108 will fund the NOER Grant. SB104 makes an appropriation for green school yards. AB501 authorizes certain people to receive academic credit for completing certain outdoor recreation activities.

Has met with Anna Cannon, from NV State Clay Target league, working to get schools in Nevada to participate. No cost to the school and a great fit for an extra circular activity. Currently no schools in Nevada participate. Outdoor Recreation Economic Impact study should be finished by end of April.

Elisabeth Johnson: Enrolled in the Certified Public Manager program, which includes doing a capstone project. This project will be a collaboration effort with Department of Motor Vehicles (DMV) to promote Off Highway Vehicle (OHV) registration to enhance the OHV Grant program. Also working on the Boulder City Lighting retrofit project, replacing all municipal bulbs to use less energy and light pollution.

Jasmina Sekanovich: Just completed her portion of the Statewide Comprehensive Outdoor Recreation Plan (SCORP). Previously her position had been grant funded, DCNR is changing the position to IT Enhancement to support NDOR, to be filled in October. Until then she has applied for the OHV Grant fund to cover her position until October. Trail Finder is getting about 150 views a day. Challenge badges launched last year. This month is the ranger badge. Next update to Trail Finder is trail side services that should be launched by summer. She has created six kiosk maps since starting.

Amy Berry: Is there a marketing budget or social media? Can you see the metrics of where visitors are coming from?

Jasmina Sekanovich: No marketing budget, we have created rack cards, had ads in magazines and tabling at events. We have a global distribution map to see where visitors come from. Chad Taylor: Has received comments some of the best maps Hollywood has ever used.

Chelsea Kincheloe: Trails news – Truckee Meadows Community College (TMCC) has a private funder that wants to fund three years of a trail certification program. This would provide skills for nonprofit groups and trail professionals. We are currently developing the curriculum and hoping to launch in Spring of 2026. We are growing followers on Instagram and Facebook, from 600 to 1,100. Changed from Listserv to Mailchimp for our newsletter.

She oversees the Nevada Outdoor Recreation Infrastructure Grant. She currently has four grants closed out.

NV Starry Skies – Launched the program in October 2024, working mostly with outreach. This program came from SB52, and Nevada is the first state to pass a certification for lighting. Cosmos in the Desert is the first ever Dark Skies Festival in NV to be held on April 26, 2025.

Astronomical Society of Nevada will be there with telescopes, as well as Nevada Department of Wildlife (NDOW) with kayaks and nocturnal lead walks. Working on a Dark Skies tool kit with Travel Nevada. NDOR has a new website.

Mauricia Baca: Is there a connection with the Dark Skies license plate and your work?

Chelsea Kincheloe: Currently working on it, the funds go to Friends of NV Wilderness. Monitoring Astro Tourism, outreach and education.

Amy Berry: Do you have an estimated amount of event attendance?

Chelsea Kincheloe: The current visitation for Lahontan in April is around 250 people and the reel that was posted has over 4,000 views.

Stavros Anthony: Who can apply for certification and examples of how do they get certified?

Chelsea: Reducing overall lighting of the location, and retro fitting with dark sky compliant lighting. It must be 3000 kelvins or lower. You create a lighting plan, and once fully implemented then you get the certification and submit a yearly report. People who can get certified are schools, parks and open spaces, businesses, HOAs, municipalities, or an entire area.

Kaden Barmore: Currently in our second and final grant round for the fiscal year. Have 29 applicants and have been awarded 7 grants so far. Working to modernize and update the program. Organizing to make an accessible program, doing a complete rebrand of the program, updated the logo, and updating with a new website. Doing lots outreach and education.

Debra Strickland: Announcing a soft opening on Saturday of a new track in Pahrump with OHV Grant funds, will be offering vin inspections and registration.

Kendal Scott: The Outdoor Education Advisory Working Group (AWG) was tasked with coordinating better integration of outdoor recreation into school systems. NDOR applied for a national program called Nature Everywhere, and we are the first state to be selected for that program. It allowed us to conduct a survey with focus groups of students and teachers with over 50 participants. The AWG then took all that information and made a report. The report

centers around content, integration, capacity building, outdoor learning infrastructure and policy. Proposed in AB 165 is the opportunity to expand the work of the AWG and create a new council.

NOER Grant Awards – First project wrapped up last week that was an Urban Beekeeper project. There are 21 new projects for the 2025 grant round. Working with other grant managers to standardize forms and establish metrics. The NOER Grant impact report talks about how many people applied, projects able to fund and number of participants. We reached more participants than the estimated goal. Requesting feedback from the last TAC grant round.

Debra Strickland: This grant round was her first time and found it easy.

Robert Mergell: The changes in the scoring made the scoring fairer.

**8. PRESENTATION FROM** Gregg Berggren and Lyndsey Boyer of Carson City Parks, Recreation & Open Space. They will speak about the city's strategic plan for open space and outdoor recreation, with a focus on conservation and stewardship during the planning process. (45 MINUTES).

Cheva Gabor: Would like to see this presented to neighboring jurisdictions to improve connectivity.

Mauricia Baca: Thinks other jurisdictions could really benefit from this presentation.

Stavros Anthony: Is the ¼ of 1% from sales tax? Yes.

Amy Berry: Would love to see a revenue chart.

**9. PRESENTATION FROM** Brandon Bishop, Program Manager for the Conserve Nevada Program, will give an overview of Conservation and Recreation Bonds in Nevada. This will include a brief historic overview of what has been done, statewide impact of this funding source, historic projects, active projects, Conserve Nevada funding opportunities moving forward, the grant round for 2024, and long-term program goals and questions.

Mauricia Baca: Appreciates the presentation and this type of work.

Robert Mergell: The Valley of Fire's new visitors center will be opening in late October and maybe we could have the meeting there.

Cheva Gabor: For the Capital Christmas tree project, we could make ornaments at the next meeting.
