1. CALL TO ORDER at 3:01pm.

2. PUBLIC COMMENT

3. REVIEW AND DISCUSSION OF LCB File R060-24

The proposed regulation change relates to the Nevada Outdoor Education and Recreation grant program. These revisions include updating eligibility for the grant program, updating the proposals reviewed by the Division of Outdoor Recreation, and updating the Technical Advisory Committee.

A copy of the draft regulation was posted along with the notice of the adoption hearing and can be found on the agency's website, ndor.nv.gov under the meetings tab. The purpose of this regulation change is to increase efficiency in administering the Nevada Outdoor Education and Recreation grant program.

The first update will be in NAC 407A.140 section 2 subsection 4, to eligible activities. This edit repeals "organized youth sports, including without limitation,

community leagues and school teams” as an ineligible activity for funding. Instead, the types of teams or leagues eligible for funding will be clarified in more detail in the grant manual.

Next, in 407A.145 section 3 subsection 2, this update allows for the division administrator to approve or disapprove an application for a grant that requests equal to or less than \$7,500 rather than referring the application to the Advisory Board on Outdoor Recreation. This changes that amount from the previous \$5,000. We have proposed an amendment to the LCB draft regulation to include “equal to or less than \$7,500” rather than “less than \$7,500”.

Finally, this update repeals NAC 407A.150 and the definition of Technical Advisory Committee in 407a.125. This is to comply with more current law, which established that the Advisory Board on Outdoor Recreation will serve the duties of a technical advisory committee for this grant program. That change is reflected throughout the draft.

4. ADOPTION OF LCB FILE R060-24 (FOR POSSIBLE ACTION)

No discussion was provided. LCB file R060-24 was adopted as amended.
